Date(s) of Activity: 7/20/19 to 8/3/19

Description of Activity: The academy fosters the dispositions of innovators: students are invited to take risks, ask questions, and develop provisional solutions. As students create and exchange new knowledge through reading, writing, and discussion in an academic community, they also design and engineer practical solutions to real environmental problems. The Humanities component serves as an academic apprenticeship in the spoken and written discourses that are characteristic of elite high schools and highly selective colleges and universities, where students read, discuss, and write responses to complex texts in whole- class seminars, small groups, and individualized conferences. The Engineering component exposes students to different fields of engineering, while helping them develop practical skills and principles of practice for use in a variety of engineering contexts. Students select from three engineering fields -- web and application design, 3D modeling, or electronics -- and participate in collaborative projects in their chosen field. The course culminates in a symposium in which students present processes and prototypes that address how we might mitigate the negative effects of human culture on the environment.
